From Chattanooga (I-24 West Bound):

Take Exit 111 (Manchester/McMinnville) off I-24. Turn left at the end of the ramp onto Hwy 55. Drive approximately 10 miles toward Tullahoma. Park will be on the left 1/2 mile past Coca Cola Facility.

From: Nashville (I-24 East Bound):

Take Exit 111 (Manchester/Woodbury) off I-24. Turn left at the end of ramp onto Hwy 55. Drive approximately 10 miles to Tullahoma. Park will be on the left 1/2 mile past Coca Cola Facility.

From: Winchester/Shelbyville

Take U.S. 41A into Tullahoma from Winchester or Shelbyville. Turn right from Winchester, left from Shelbyville onto East Carroll Street (Hwy 55) toward Manchester. Drive approximately three miles to Waggoner Memorial Park on the right.
